

PROPERTY DAMAGE INSURANCE COVERAGE OPTIONS

A tour customer (the "Customer") must select one of the following two options for insurance against damage to or theft of the motorcycle (the "Motorcycle") the Customer is renting from CMA Tours Ltd. ("CMAT"):

1. **Purchasing Damage and Theft Coverage from CMAT for \$70.00 per day.** *Note:* With this coverage the Customer pays a deductible of \$1,000.00 on any damage and/or theft claim and (except as noted below) the Customer's liability for damage or theft is limited to the payment of the applicable deductible. Theft coverage includes theft of any motorcycle gear ("Gear") rented to the Customer by CMAT and theft of any accessories ("Accessories") installed on the Motorcycle by CMAT; but it **does not cover** any of the Customer's personal belongings. Theft coverage for the Motorcycle is included in CMAT's own insurance coverage provided that the Motorcycle was locked by Customer with all locks supplied by CMAT. Damage coverage includes all accidental (non-negligent) damage to the Motorcycle, Accessories and Gear. Both the damage and the theft coverage **exclude** coverage for injury, death, personal property and damage arising directly or indirectly from any action in breach of the Terms and Conditions signed by the Customer and/or the commission of any of the acts prohibited in the Terms and Conditions. A police report is required for all accidents and/or theft. All damages to the Motorcycle, Accessories and Gear without a police report shall be deemed to be the Customer's fault and are excluded from the coverage. The Customer is fully responsible for and shall pay all costs and expenses for damage or theft which are excluded from the coverage. **OR**

2. **Waiving the Damage and Theft Coverage offered by CMAT and self insuring.** In this case the Customer accepts responsibility for and is obliged to pay the full undepreciated retail value of any and all damage to, or theft of, Accessories and Gear. The Customer is obliged to pay a \$7,000.00 deposit to CMAT before the start of the Customer's tour and the Customer is liable for and shall also pay CMAT any additional amounts required to repair or replace the damaged Motorcycle, or damaged or stolen Accessories and Gear. CMAT shall credit the Customer back any unused portion of the Customer's deposit following the completion of the Customer's tour if the Motorcycle has not been damaged, and if the Accessories and Gear have not been damaged or stolen.

I acknowledge having read and understood these insurance options and I agree to be bound by the terms of the coverage being offered by CMAT. I authorize CMAT to charge the credit card(s) and/or debit card(s) that I have provided to CMAT for all amounts payable or owed by me to CMAT in connection with any damage or theft claim(s) relating to the Motorcycle, Accessories and Gear. I certify the driver's licence I have presented to CMAT is currently valid and is not suspended, expired, revoked, cancelled or surrendered. I confirm that I am aware that the insurance coverage is strictly limited to that described above and does not include any third party or personal liability insurance coverage.
